The mass standards described above have been compared to the standards of the State of Vermont, by NISTIR 6969, SOP 8 (2019), and have been found at time of test, or been adjusted, to meet the maxium permissible errors stated in ASTM E617-18 Standard Specification for Laboratory Weights and Precision Mass Standards. Standards of the state of Vermont are traceable to the SI and National Institute of Standards and Technology (NIST). The Vermont Laboratory is recognized by NIST, under the Laboratory Metrology Program at Mass Echelon III. The mass standards described above were found to have a mass value at the time of test as indicated in the following tabulation. Weights are considered within the MPE when the absolute value of the conventional mass correction plus the uncertainty is less than or equal to the specified MPE. Weights received with a conventional mass outside the MPE show a value in the "before adjustment" column.

The uncertainties shown are expressed as the sum of the following sources of inaccuracy; (1) Type B, systematic uncertainties relative to the reference standard and procedure used, and (2) Type A, random uncertainties determined by the standard deviation of the measurement process. Type A and Type B uncertainties are combined by the root sum squared method and multiplied by a coverage factor of k (in chart) for an approximate 95 % confidence interval.
